

## THE GREAT RESET

November 13, 2020

Last month, in the *Veritas Report's* edition on [Population Control Advocates](#), we examined the connection between global philanthropic organizations such as the Gates Foundation, the Rockefeller Foundation, and eugenics, population control, (i.e. contraception, abortion, sterilization). Moreover, these organizations also seek to use vaccines as a way to [reduce the world's population](#) and have been vocal advocates for the upcoming COVID-19 vaccine. The Gates Foundation in particular, through its founder, former Microsoft CEO [Bill Gates](#), has stated that life will not return to normal until a widespread vaccination is accomplished [this for a virus that has a 99% recovery rate].

Discussions about a “new normal” post-COVID, with health restrictions intertwined with social engineering, are now commonplace not just among a few philanthropists and public health advocates, but among most of the cadre of global elites, political and business leaders.

Most notable among them is Mr. Klaus Schwab, the head of a relatively unknown, but politically powerful organization called the World Economic Forum, which advocates for a “Great Reset” across the earth.

In this edition of the *Veritas Report*, we intend to examine the Great Reset and its connection to the COVID-19 crisis and lockdowns. ### Klaus Schwab and the World Economic Forum

The [World Economic Forum](#) (WEF) was founded in 1971, by [Dr. Klaus Schwab](#), a German-born business policy professor with a mission to promote public-private partnerships by bringing together business executives, government leaders, and other key shareholders in the world economy. Based in Davos Switzerland, the WEF helps to implement Schwab's vision for “stakeholder capitalism” an economic philosophy that places private corporations as “trustees of society”, enabling them to govern based on specific metrics including social and environmental principles.

This system would replace the shareholder led corporation model that dominates presently. The WEF organizes an annual meeting in Davos each year that is a veritable “Who's Who” of world business, religious, and political leaders. Even Pope Francis [sent a representative](#) and his greetings to the [January 2020 Davos summit](#).

*Veritas Report* asks: *Who are these “trustees of society” and will the common voter have a voice in this new economic order? Will the Church and her teachings be accommodated?*

### Neo-Technocracy

One of the pillars of Schwab's philosophy is a global society built upon technology, also called the [Fourth Industrial Revolution](#), where the world is replaced by pure technology: automation, robots, artificial intelligence, surveillance apparatus, and future scientific breakthroughs including nanotechnologies, and neuro-technologies that blur the lines between man and machine. As quoted in his book, [The Fourth Industrial Revolution](#), Schwab states: **“Sooner than most anticipate, the work of professions as different as lawyers, financial analysts, doctors, journalists, accountants, insurance underwriters or librarians may be partly or completely automated...”**

Schwab's faith in technology is fully unveiled in another of his books, [Shaping the Future of the Fourth Industrial Revolution](#), which promotes super-humans:

**“We will become better able to manipulate our own genes, and those of our children. These developments raise profound questions: Where do we draw the line between human and machine? What does it mean to be human?”**

While moral ethics appear to be of limited concern in the new future, civil liberties are even less so in Schwab's technological surveillance state in which he envisions mind-reading technologies to aid in police work:

**“... the temptation for law enforcement agencies and courts to use techniques to determine the likelihood of criminal activity, assess guilt or even possibly retrieve memories directly from people's brains will increase.”**

Many other aspects of life and economic changes are proposed in Schwab's [books](#) including geoeengineering, climate change, and family life:

**“Thanks to the combination of historical migration patterns and low-cost connectivity, family structures are being redefined.”**

*Veritas Report* asks: *Will the traditional family and the traditional means of worship and socializing, from Mass to family gatherings and dinners, to local heritage and traditions even be allowed in this new [world] order?*

### The Great Reset

In order to usher in this new society built on technology and governed by stakeholder trustees in a private-public partnership, Schwab and the WEF propose a global economic and societal “reset” where the normal world is replaced with a new global order. According to the [World Economic Forum website](#):

**“...the world must act jointly and swiftly to revamp all aspects of our societies and economies, from education to social contracts and working conditions... In short, we need a “[Great Reset](#)” of capitalism.”**

The Great Reset is built on changes based on three elements:

- **Fiscal:** Reorientation of tax, trade and regulatory policies that are focused on “fair outcomes” and establish the conditions for Schwab’s “stakeholder” economy
- **Investments:** Building on the fiscal, will be the development of new government large-scale spending programs based on “equality and sustainability” using environmental and social “metrics”
- **Social and Technological:** Utilizing technologies to re-orient and transform society.

Included in the above Great Reset diagram are "LGBTI inclusion" and "Gender Parity"

*Veritas Report asks: Are these principles essentially picking winners and losers in society? What if someone or some nation or some religion (e.g. the Catholic Church) did not want to participate in the Great Reset?*

*Are certain “buzz phrases” that commonly appear in the media associated with the Great Reset? (e.g. climate change, sustainability, social change, equality)?*

## **How will the Great Reset be implemented and enforced?**

On November 2nd, Time Magazine published a special feature which promoted Schwab and the [Great Reset](#). It contained an eerie and well-designed road-map telegraphing how the Great Reset would be tied to social engineering and climate change and require some type of [global government](#).

*Veritas Report asks: If a new type of global governing system is proposed, how will it react to a global religious institution, like the Catholic Church, which has authority to cast judgement upon actions of governments?*

*Should we Catholics have concerns about this reset?*

## **COVID-19: Ushering in the Great Reset?**

As we have noted in the past, the COVID-19 virus is a real virus that can pose a threat to a small segment of the population, particularly those with vulnerable health conditions. The WEF however, has seen that the virus isn’t as much of a threat, but an opportunity to push to reorient society into a [global technocracy](#).

**“... the pandemic represents a rare but narrow window of opportunity to reflect, reimagine, and reset our world to create a healthier, more equitable, and more prosperous future.”**
